FREQUENTLY ASKED QUESTIONS

QUESTION #1: WHY DOES NEVADA NEED A STATE APPLIANCE STANDARD?

States have historically led the nation in the development of new efficiency standards for residential and commercial products. Over time consensus efficiency standards develop into national standards. By setting state efficiency standards, Nevada can help accelerate the adoption of energy-saving products across the region and country.

QUESTION #2: WILL NEVADANS NEED TO REPLACE EXISTING APPLIANCES?

No. Efficiency standards merely raise the floor for products available for new purchases and do not require changing out of products currently in use. The recommended standards are also set to ensure consumers and businesses will have numerous choices of qualifying products to purchase.

QUESTION #3: WHICH PRODUCTS ARE COVERED?

Air Purifiers, Commercial Dishwashers, Commercial Fryers, Commercial Hot-Food Holding Cabinets, Commercial Ovens, Commercial Steam Cookers, Computers and Computer Monitors, Electric Vehicle Supply Equipment, Gas Fireplaces, High CRI Fluorescent Lamps, Portable Electric Spas, Residential Ventilating Fans and Water Coolers.

QUESTION #4: HAVE OTHER STATES ADOPTED SIMILAR STANDARDS?

Yes! Since 2017, California, Colorado, Hawaii, Nevada, New York, Vermont, Washington, and Washington, DC, have updated their standards. An additional 12 states are currently moving legislation to update standards or are demonstrating interest. We should not be left behind.
