DOE is required to review each standard at least once every six years and issue either a notice that no revision is needed or a notice of proposed rulemaking and, two years later, a final rule. We note below each product any legal deadlines that DOE has missed as well as any dates that are ASAP estimates. Items in **this shade** have been completed. The estimated or required date for items in **this shade** has passed without DOE completing the item. Items not shaded are expected on the date indicated.
