We accounted for the interaction effects among irrigation controllers and spray sprinkler bodies in calculating the total water savings. The total potential water savings are thus smaller than the sum of the individual products.

While we continue to recommend the adoption of state-level standards for commercial hot-food holding cabinets and computers and computer monitors, we have not estimated savings for these products due to insufficient data on the current market. We accounted for the interaction effects among irrigation controllers and spray sprinkler bodies in calculating the total savings. The totals are thus smaller than the sum of the individual products.
